7.2 Noted:

We are now covered with Frank Risk Management for full replacement Insurance but this is based on an old valuation of \$1.2million. That valuation is expected will be superseded when/if a new valuation is commissioned. That commissioning however, does depend on getting some answers from DOC as to whether we would be allowed to rebuild the lodge if it were destroyed. No point in paying for full cover on say a \$2million structure if you would not be allowed to rebuild it after destruction.

8. Building Warrant of Fitness

8.1 Considered:

An oral report from the Finance Officer.

8.2 Noted:

(i) The mechanical ventilation system was not inspected by an IQP at the BWOF renewal date in March 2023 and not subsequently due to the need to get a new IQP and this step has been fraught with difficulties. Consequently Ruapehu District Council or RDC have concluded that it is now too late for this BWOF year to issue a BWOF or to go through the s-rad and b-rad process, which is essentially a "please explain" when difficulties arise. Instead RDC have asked us to ensure that we have an IQP ready and waiting to inspect the mechanical ventilation system at time of our BWOF renewal date of 20th March 2024 and that the necessary 12a form is sent to our BWOF coordinator RFS Fire and Safety, Aka Richdales, who will then issue (or trigger) the BWOF with RDC. The new Independently Qualified Person or IQP is Jason Constable @gmail.com is his contact and John has an

agreement to trigger an instruction early in the new year for Jason to do this inspection.

(ii) All other aspects of the BWOF as inspected by RFS have been found satisfactory and were ready for BWOF approval and only the Mechanical Ventilation inspection let the process down.

9. RMCA AGM

9.1 Considered:

- (i) The request from DoC for help to clean up the mountain. Possible during times when clubs hold their work parties;

- (v) Tūwharetoa not bidding, not viable, professional advice;
- (vi) Private ownership (Pure Turoa Ltd, Whakapapa Holdings Ltd, MBIE) vs public ownership (community, RSSA, iwi);
- (vii) RSSA donations (professional advice, insolvency law, litigation, and government relations);
- (viii) The RAL Liquidation Committee (staff, trade creditors and life pass holders) reported that PwC are refusing to provide timely and accurate information, have instructed a barrister to commence a formal exchange of letters.
